

## **WAIVER OF LIABILITY**

I hereby acknowledge and agree to the terms and conditions set forth in this Release of Liability. I understand that by participating in the yoga class ("Event") organized by the Madison Museum of Contemporary Art (MMoCA), I am voluntarily assuming certain risks associated with physical activities, including but not limited to yoga, which are being offered and conducted at an acceptable standard of care applicable to the activity.

In the event of an illness, injury or medical emergency arising during or after the Event I agree that I will be fully responsible for payment of any and all medical services and treatment rendered to me including but not limited to medical transport, medications, treatment and hospitalization. I certify as a pre-condition to my being permitted to register for and participate in this Event that I am of a physical condition suitable for the completion of this Event.

In registering for and participating in this Event, I waive and forever release any and all liabilities and claims for damages, expenses or personal injuries that I may have against MMoCA and their owners, directors, affiliates, officers, contributors, sponsors, employees, contractors, agents, and volunteers, for any and all injuries to me or my personal property. I recognize, intend and understand that this release is binding on my heirs, executors, administrators, or assignees. I am aware that I am waiving certain legal rights, including the right to sue or any legal action or proceeding related to this agreement or the Event.

I expressly agree that this consent is intended to be as broad and inclusive a release of liability as permitted by applicable law and that if any provision thereof is held invalid, it is agreed that the remaining provisions shall, notwithstanding, continue in full legal force and effect.

**Media Release:** I hereby give my consent to be photographed, recorded, and/or videotaped for use by MMoCA in the production of any and all media for marketing and/or educational purposes. MMoCA shall have the irrevocable, royalty-free, non-exclusive license to use, display, publish, exhibit, and distribute all or portions of the photographs, films, videotapes, audio recordings and copies of images recorded from the Event.
