# 2025 ART FAIR ON THE SQUARE • JULY 12 & 13 ENTERTAINER INFORMATION

The Madison Museum of Contemporary Art (MMoCA) will present the 67th annual Art Fair on the Square on July 12 & 13, 2025. Read the following information carefully before applying.

#### **Application Process**

To be considered, submit the application (and a photo if applying for the first time).

#### **Option A: Online**

#### **Option B: Paper Application**

#### Location, Dates, and Times

The fair takes place on city streets surrounding Wisconsin's State Capitol Building in Madison, WI. Entertainers will be assigned to one of the stages during the event. The event times are as follows:

Saturday, July 12: 9 am - 6 pm

Saturday, July 12: 9 am - 6 pm Sunday, July 13: 10 am - 5 pm

#### **Evaluation Criteria**

Your application will be evaluated based on:

- Crowd interaction & engagement
- Suitability for all ages
- Past Art Fair and other event experience.

#### **MMoCA Cancellation Policy**

If MMoCA finds it necessary or is legally obligated to cancel the 2025 Art Fair on the Square at any point due to any of the following causes, to the extent beyond its reasonable control: Acts of God, accident, riots, war, terrorist act, epidemic, pandemic, public health crises, quarantine, civil commotion or unrest, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, explosion, forced evacuation, or sudden lack of availability of event site.

#### **Merchandise Sales**

MMoCA allows the collection of donations as well as the sale of items to promote your group/music/organization such as CDs, T-shirts, etc. This is permissible during, and up to 15 minutes before & after your performance.

#### **Food and Beverages**

MMoCA does not have their own concessions and does not offer food & beverage coupons to entertainers for Art Fair on the Square performances.

#### **Animals and Pets**

In 2010 the Madison Common Council banned dogs, cats and all other animals from Madison's major street events, including Art Fair on the Square.

#### Security

Though the fairgrounds will be monitored by security and off-duty police officers, entertainers are responsible for securing all of their materials.

#### **State Capitol Building Driveways**

Entertainers may not park vehicles or trailers in the driveways of the State Capitol Building. Entertainers will receive a parking pass to park in designated locations for the event during their performance. Vehicles parked in locations not designated and not authorized will be towed.

#### **Stage Assignments**

Per the permit granted by the Capitol Police, performers are only allowed to perform in specific places on the Capitol grounds. MMoCA will try to honor requests, but please understand that electricity requirements and construction restrictions, etc., impact entertainer placement.

**NOTE:** Due to construction the State Street Stage will not be available for 2025. We are currently looking for alternative locations for additional stages and will update when they are finalized.
